#### INTRODUCTION:

- 1. KPT Hut No.97/98-S was constructed in the year 2011-12 and is being used by hi-ups and official dignitaries. Therefore, it is mandatory to keep the same in well maintained condition.
- 2. Due to harsh weather conditions, it is quite essential to undertake the different repair work periodically in-order to avoid any untoward incidents. Keeping in view the said scenario the subject work is very much necessary to be attended.(Photographs are placed at S.No.1)
- 3. Accordingly, AXEN (M) after carrying out a survey has prepared an Estimate amounting to Rs.4,793,460.00 alongwith a plan placed at S.No.2(A) & 2(B) respectively, to attend the same through outsource as the same is beyond the scope of In-house arrangements of labours and materials.
- 4. Tenders for the work were therefore re-invited under 36 (a) of PPRA Rules through Press on 21-04-2024 and KPT / MoMA & PPRA Website on 26-04-2024 and received on 13-05-2024.

The Single Evaluated / Most Advantageous Bid amounting to Rs.5,142,884.25 (Rupees: Five Million One Hundred Forty Two Thousand Eight Hundred Eighty Four & Twenty Five Paisa Only) received in accordance under Clause PPRA Rule 36 (a) from M/s. AJJ Enterprises which is 07.28% above the corresponding estimated cost of Rs. 4,793,460.00 based on KPT schedule of rates 2023-24 is considered reasonable. Keeping in view of their past performance as mentioned in para (m), M/s. AJJ Enterprises is considered capable for carrying out the work viz. "MAINTENANCE / REPAIR TO GUARD ROOM, GENERATOR ROOM, PROJECTION OF HUT & ALLIED REPAIR WORK TO KPT HUT 97/98-S AT SANDSPIT MANORA".
