NAME OF WORK: MAINTENANCE & REPAIRS BOUNDARY WALL AT OLD DEMOLISHED KPT EX-KHALASY BUILDING NEAR JUNGLE SHAH COLLEGE, KEAMARI.

INTRODUCTION:

1. Manager (Anti- Encroachment) vide his letter placed at S.No. 1 has intimated that the subject plot is opened from one side, due to opening of this side local public of the area has made illegal cattle farm within premises of plot. Therefore, Manager (Anti Encroachment) has requested through Estate Department to remove the same to avoid any encroachment in future. However to curb this practice, it is the dire need to build / construct a wall, accordingly, AXEN (KV) has surveyed the site and prepared an estimate alongwith plan amounting to Rs.996,352.00 placed at S.No.2 (A) & 2 (B) respectively, to attend the work, as the same is beyond the scope of In-house arrangements of K.P.T.
2. Tenders for the work were therefore invited under 36 (a) of PPRA Rules through KPT, MoMA & PPRA Website and received on 22-04-2024.
