

NAME OF WORK: MAINTENANCE /REPAIR AND REPLACEMENT OF WORN OUT FRESH WATER (OPEN) LINE AT RESIDENTIAL BUILDING OF KV-81 & 82 NEAR FOOTBALL GROUND KEAMARI.

INTRODUCTION

1. The Residents' of KPT Building No. KV-81 & 82 vide their application placed at S.No.1 have requested for the repair & maintenance works of their official KPT accommodation, which is in dilapidated condition.

The accommodation was visited by AXEN / Sub Engineer (WS) and it was observed that, the fresh water line has rusted and got damaged / worn out at several points & due to that, wastage of fresh water has been observed & the same needs repair on urgent basis.

Accordingly, AXEN (W/S) has prepared an estimate alongwith a plan placed at S.No.4 (A), to attend the through outsource as the same is beyond the scope of in-house arrangements.

2. According to Rule-36(a) of PPRA tenders for the work were invited through KPT / PPRA & MoMA Website 27-08-2024 and received on 19-09-2024.
