

It is therefore, necessary to attend the work to overcome the situation through a running contract for 06 months period. Accordingly, AXEN (MIY) has prepared an estimate amounting to Rs.998,602.50 (including Taxes and Contingencies) placed at (F/B) to attend the work through contract as the same is beyond the limits of in-house arrangements.
2. Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through KPT, MoMA & PPRA Website and received on 03-10-2024.
