



**INTRODUCTION:**

1. Amidst, the handing over of East Wharf to KGTL, the entire Port activity has been shifted to West Wharf, which includes frequent visits of dignitaries. In-order to keep the gates aesthetically appealing. AXEN (MIY) has prepared an estimate amounting to Rs.967,207.50 (including Taxes and Contingencies) placed at S.No.2 to attend the work through outsources as the same is beyond the limits of In-house arrangements.  
It is pertinent to mention here that, no work has been done since last 06 years at the subjected gates, resulting the marble walls outside the gate Lodge giving shabby looks.
2. Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through KPT, MoMA & PPRA Website and received on 03-10-2024.


**RECOMMENDATIONS**

The Single Evaluated Bid amounting to Rs.996,942.19 (Rupees: Nine Hundred Ninety Six Thousand Nine Hundred Forty Two & Nineteen Paise Only) received in accordance under Clause PPRA Rule 36 (a) from M/s. New Ghulam Nabi Enterprises which is 0.07% above the corresponding estimated cost of Rs.967,207.50.00 based on market rates is considered reasonable. Keeping in view of their past performance as mentioned in Para-2 (m) M/s. New Ghulam Nabi Enterprises is considered capable for carrying out the work viz. **"GRINDING AND POLISHING OF GATE NO. 18 (LLYOD GATE) & MOHIUDDIN GATE AT M.I. YARD WEST WHARF."**
