**INTRODUCTION:**

1. Apartment Jinnah Bridge descending towards west wharf side are covered visual barriers, as per the security concern for port area, with the passage of time these sheets have been rusted & requires replacement. Accordingly, AXEN (MIY) has prepared an Estimate amounting to Rs.995,971.83 (including Taxes and Contingencies) placed at S.No.1, for attending the work, as the work is beyond the capacity of KPT In-house arrangements.
2. Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through KPT, MoMA & PPRA Website and received on 27-08-2024.

**RECOMMENDATIONS**

The Single Evaluated Bid amounting to Rs.999,581.78 (Rupees: Nine Hundred Ninety Nine Thousand Five Hundred Eighty One & Seventy Eight Paise Only) received in accordance under Clause PPRA Rule 36 (a) from M/s. Global Construction & Engineering which is 0.36% above the corresponding estimated cost of Rs.995,972.00 based on market rates is considered reasonable. Keeping in view of their past performance as mentioned in Para-2 (m) M/s. Global Construction & Engineering is considered capable for carrying out the work viz. **“FIXING OF VISUAL BARRIER SHEETS AT WEST WHARF SIDE ON JINNAH BRIDGE”**.

The Committee therefore, recommends the acceptance of the Single Evaluated Bid amounting to Rs.999,581.78 (Rupees: Nine Hundred Ninety Nine Thousand Five Hundred Eighty One & Seventy Eight Paise Only) received from M/s. Global Construction & Engineering is considered reasonable for the work viz. **“FIXING OF VISUAL BARRIER SHEETS AT WEST WHARF SIDE ON JINNAH BRIDGE”**.
