

NAME OF WORK: MAINTENANCE AND ESSENTIAL REPAIR WORKS TO KOLACHI PIER EAST WHARF.

INTRODUCTION

The Kolachi Pier is presently used for the movement of VVIP's and KPT Officials since 2002. With the passage of time, due to its location & extreme climatic conditions, the condition of apparent structure require some maintenance work. Although the minor repairing work of the structure have continuously been attended through departmental labours, but for the reason of direct hits by the boats / launches and extreme climates effects near to sea structure require immediate maintenance to keep in working condition. As the scope of work is beyond the departmental labours, therefore, to attend the necessary work under the Direction of High-Ups of KPT, a survey was made by AXEN (KW) for making an Estimate for the essential works in which scope of works includes repair / maintenance of the following works:-

- General Repair / maintenance Works.
- Repair / Renovation of Toilets.
- Repairs of Doors & Windows.
- Repair of Hand Rail, etc.
- Water Proofing, etc.
- Other allied repair works.

Tenders for the work were therefore invited through KPT / PPRA Websites and received on 23-02-2021 Accordingly to under rule 36(a) of PPRA
