

INTRODUCTION

Quiet & often it has been observed that the RCC Railing of North Over Bridge & Electric Pits at East Wharf are getting damaged due to accidents caused by the continuous movement of heavily loaded cargo vehicles. These damages are required to be repaired on immediate basis. As per routine, the cost of these damages have already been recovered from the incurs vehicles and deposited into KPT account, through Challans.

Since, the Railing of North over Bridge and Electrical Pits requires immediate attention for its necessary repair in order to avoid any mishap. Therefore, to execute the work especially at odd times on immediate basis, there is no option left but, to attend the work through outsourcing, as such, no skilled Departmental labor exists in the Sub Division for attending the following scope of work.

Therefore, Tenders for the work were invited through KPT / PPRA Websites and received on 20-10-2021, accordingly under rule 36(a) of PPRA.
