#### INTRODUCTION

The resident of KPT Flat No.EK-85 of KV-52 building vide application placed at S.No.1 has requested for the repair / maintenance works of official KPT accommodation, which is in dilapidated condition. The accommodation was visited by AXEN / Sub Engineer (KV) and observed that the KPT official accommodation is in much dilapidated condition and needs repair to make the same in livable condition. Accordingly, AXEN (KV) has prepared an estimate amounting to Rs.976, 599.84 alongwith Plan placed at S.No.2 (A) & 2 (B) respectively, to attend the same through outsource as the same is beyond the in-house arrangement. It is pertinent to mention here that, no work done since last 05 years at subject building.

Therefore, Tender for the work were invited through KPT / PPRA Websites and receive on 30-01-2023, accordingly under rule 36(a) of PPRA.
