

**NAME OF WORK: MAINTENANCE / REPAIR TO DIESEL SHOP AT MANORA WORKSHOP.**

**INTRODUCTION:**

Mechanical Engineer (Manora Workshop) vide his letter placed at S.No. 1 has intimated about deteriorated condition of Diesel Shop at Manora. Accordingly, Asstt. Executive Engineer (M) after carrying out detailed survey has prepared an Estimate amounting to Rs.6,790,220.00 along with Plan placed at S.No. 3(A) & 3(B) respectively for attending the work through outsources which are beyond the capacity of in-house arrangements. Tenders for the work were therefore re-invited under 36 (a) of PPRA Rules through Press on 01-03-2024 and KPT / MoMA & PPRA Website on 04-03-2024 and received on 21-03-2024.

The Lowest Evaluated / Most Advantageous Bid amounting to Rs.5,287,236.21 (Rupees: Five Million Two Hundred Eighty Seven Thousand Two Hundred Thirty Six & Twenty One Paisa Only) received in accordance under Clause PPRA Rule 36 (a) from M/s. The Expert which is 22.13% below the corresponding estimated cost of Rs. 6,790,220.00 based on schedule of rates and as per current market rates is considered reasonable. Keeping in view of their past performance as mentioned in para (m), M/s. The Expert is considered capable for carrying out the work viz. **"MAINTENANCE / REPAIR TO DIESEL SHOP AT MANORA WORKSHOP"**.

The Committee therefore, recommends the acceptance of the Lowest Evaluated / Most Advantageous Bid amounting to Rs.5,287,236.21 (Rupees: Five Million Two Hundred Eighty Seven Thousand Two Hundred Thirty Six & Twenty One Paisa Only) received from M/s.
