INTRODUCTION:

 Administrator Officer, KPT Hospital vide her letter placed at S.No.1 has requested to attend the subject work on priority as the same area is highly sensitive, regarding security measures hence requires special attention in-order to avoid any untoward incident.

Accordingly, after joint survey AXEN (KV) has prepared an estimate amounting to Rs. 6,631,467.00 alongwith plan placed at S.No. 3 (A) & 3(B) respectively, to attend the work through outsource, as the same is beyond the scope of In-house arrangements of K.P.T.

2. Tenders for the work were therefore invited under 36 (a) of PPRA Rules through Press on 28-09-2023 and KPT / MoMA & PPRA Website on 02-10-2023 and received on 16-10-2023.

Past performance of the tenderer recommended M/s.New M.S Builders is registered in C-6 Category with Pakistan Engineering Council. They have carried out many works for KPT, and their past performance on those works satisfactory.

FINDINGS & RECOMMENDATIONS:

The Lowest Evaluated Bid amounting to Rs.5,417,559.00 (Rupees: Four Million Four Hundred Seventeen Thousand Five Hundred Fifty Nine Only) received in accordance under Clause PPRA Rule 36 (a) from M/s. New M.S Builders which is 18.30% below the corresponding estimated cost of Rs.6,631,467.00 based on KPT draft amended schedule of rates (2002) 2013 and as per current market rates is considered reasonable. It is further submitted that at the time of opening of bid M/s. New M.S Builders provided expired copy of PEC. During the meeting of DTC, all the members of the committee agreed to obtain the renewed PEC of the Lowest Bidder. Accordingly, Lowest Evaluated Bidder M/s. New M.S Builders was asked to provide the same, in response the bidder M/s. New M.S Builders provided the renewed valid PEC, which fulfils our requirement to consider the tender.

Keeping in view of their past performance as mentioned in para (m), M/s. New M.S Builders is considered capable for carrying out the work viz. "PROVIDING AND FIXING OF BARBED WIRE & MISCELLANEOUS WORK OF SECURITY WALL AT KPT HOSPITAL, KEAMARI".

The Committee therefore, recommends the acceptance of the Lowest Evaluated Bid amounting to Rs.5.417.559.00 (Rupees: Four Million Four Hundred Seventeen Thousand Five Hundred Fifty Nine Only) received from M/s. New M.S Builders is considered reasonable for the work viz. "PROVIDING AND FIXING OF BARBED WIRE & MISCELLANEOUS WORK OF SECURITY WALL AT KPT HOSPITAL, KEAMARI".

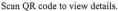

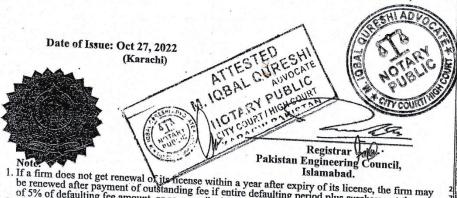
