Accordingly, AXEN (Q/R) has prepared an Estimate amounting to Rs. 952,819.00 alongwith a Plan placed at S.No. 1(a) & 1(2) respectively, to attend the work through outsource as the same is beyond the scope of In-house arrangements.
2. Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through KPT, MoMA & PPRA Website and received on 21-03-2024.
