To attend complaints AXEN (QR) survey the said location & has prepared an estimate amounting to Rs. 900,795.00 (including Taxes and Contingencies) placed at S.No. 1, to attend the work through outsources as the same is beyond the limits of in-house arrangements.
2. Tenders for the work were therefore, invited under 36 (a) of PPRA Rules from Contractors through KPT, MoMA & PPRA Website and received on 24-09-2024.

RECOMMENDATIONS



Keeping in view of their past performance as mentioned in Para-2 (m) M/s. New Ghulam Nabi Enterprises is considered capable for carrying out the work viz. **“MAINTENANCE / REPAIR OF SEWERAGE LINE AT CLUB ROAD LALAZAR AREA”**.
