

NAME OF WORK: MAINTENANCE / REPAIR TO FIRE STATION BUILDING AT KEAMARI.

INTRODUCTION

The KPT Central Fire Station building was constructed in early 80's by the KPT to coop up the requirement of fire fighting services for the KPT as well as to facilitate the city needs. This building is about 40 years old and with the passage of time shows the signs of destruction in shape of spoiled concrete cover by virtue of its nature that the same lying very near to the shore environment.

The Assistant Executive Engineer (KV) visited the structure along-with the Port Fire Officer and reveals that the structure needs comprehensive repair/refurbishment of its structural members. Considering the budget constraints in the current fiscal year, it was decided by the KPT higher management to take up some emergent nature of work for the structure within the budget to keep the same safe upto some extent, however the comprehensive repairs is planned for the next fiscal year as per budget allocation.

the light of the directions of KPT management the Assistant Executive Engineer (KV) prepare the estimate for the emergent nature of work of repairs to keep the building in good ship shape condition.

Tenders for the work were therefore invited through KPT / PPRA Websites and received on 24-03-2020. Accordingly to under rule 36(a) of PPRA
