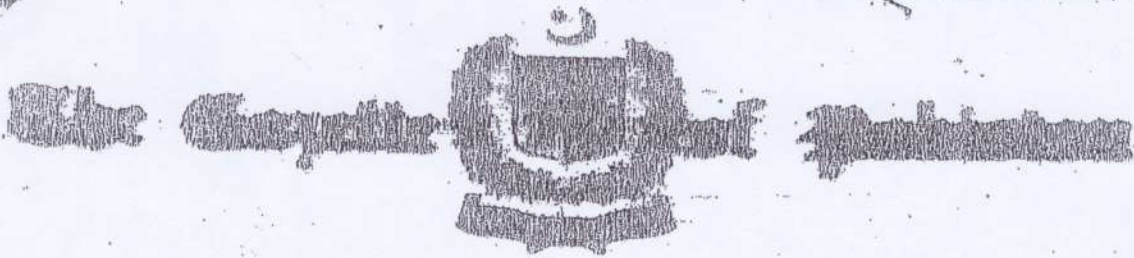

 that the following further amendments shall be made in their Notification No. S.R.O. 1(KE)/2003, dated the 15th November, 2002 namely:-

In the aforesaid Notification in SECTION -4-

(a) In clause 0406, for sub-clause 'a', the following shall be substituted, namely:

"a" Subject to availability of space in the Transit Sheds/Plinths/Coal Yard bulk import/export/in-transit consignments may be stored at the sole risk and cost of the importers/exporters only upon prior written approval of Traffic Manager at the rates given below:-

Commodity Import/ export/in-transit	Location	Rate / Sq. meter/annum
Coal	Coal Yard (Open area) T-Series East & West Wharf	Rs. 540-00
Other Bulk Commodities	East & West Wharf (Open area)	Rs. 1,000-00
	East & West Wharf (Covered area)	Rs. 2,000-00

Note: For export, either local or in-transit bulk commodities, rental charges shall be freezed on payment of wharf-age charges. However, rental charges will be applicable after sailing of vessel on leftover cargo.

(b) in clause 0407, sub clause (d) alongwith its rates in tabular form shall be omitted and

(c) Under the heading "Amplifying Notes" for SAN-21 the following shall be substituted namely:-

"SAN-21"

Slabs	Rates
Import/export/in-transit bulk cargo stored under item "e" of Clause 0406 shall be charged as under:	
First 30 days from the date of possession	As per item "e" Clause 0406
Next 30 days	50% increase in the rates referred in item "e" Clause 0406
Thereafter (till clearance)	100% increase in the rates referred in item "e" Clause 0406
