ORDER

Islamabad the 10 October 2018

S.R.O.1260(I)/2018 dated 10 October 2018 – WHEREAS the United Nations Security Council vide its Resolutions Nos. 1718(2006), 1874 (2009), 2087 (2013), 2094 (2013), 2270 (2016), 2321 (2016), 2356 (2017), 2371 (2017), 2375 (2017) and 2397 (2017) has directed to apply certain measures relating to the Democratic People’s Republic of Korea;

AND WHEREAS the United Nations Security Council vide its Resolution No. 2231(2015) has directed to apply certain measures relating to the designated entities of the Islamic Republic of Iran;

AND WHEREAS the Section 2 of the United Nations (Security Council) Act, 1948 (XIV of 1948) empowers the Federal Government to apply certain measures to give effect to the decisions of the United Nations Security Council;

AND WHEREAS, in exercise of the powers conferred by the Section 2 of the United Nations (Security Council) Act, 1948 (XIV of 1948), the Federal Government has issued various S.R.Os to take necessary measures for implementation of the above resolutions (which can be accessed at: <http://www.secdiv.gov.pk/page/sro-unscr-sanctions>);

And Whereas the UNSC regularly updates the list of individuals and entities designated under the aforementioned resolutions which are then notified by SROs. A list of such entities and individuals, updated on regular basis, is available at the below mentioned links:

And Whereas the individuals and entities designated under the aforementioned resolutions are subject to sanctions including assets freeze, travel ban and ban on provision of any funds, financial assets or economic recourses. Such sanctions also extend to any funds, financial assets and economic resources indirectly owned by the designated individuals, and to individuals or entities acting on their behalf or on their direction;

And Whereas under the aforementioned UNSC Resolutions and SROs, there is a list of items prohibited for export to and import from the DPRK. A list of such items, updated on regular basis, is available at the below mentioned link;
