**ORDER**

*Islamabad the 17 October 2018*

**S.R.O. 1269(I)/2018** - In continuation of S.R.O No 1063(I)/2006 dated 20 October, 2006 and subsequent notifications (S.R.O. No. 1289(I)/2006 dated 30 December 2006, S.R.O. No. 667(I)/2009 dated 18 July 2009, S.R.O. No. 690(I)/2009 dated 27 July 2009, S.R.O. No. 697(I)/2012 dated 06 June 2012, S.R.O. No. 219(I)/2013 dated 19 March 2013, S.R.O. No. 403(I)/2016 dated 02 May 2016, S.R.O. Nos. 78(I)/2017 and 77(I)/2017 dated 18 January 2017, S.R.O. No. 692(I)/2017 dated 04 July 2017, S.R.O. Nos. 953(I)/2017 and 954(I)/2017 dated 15th September 2017, S.R.O. No. 1221(I)/2017 dated 21 November 2017, SRO No. 64(I)/2018 date 25 January 2018, SRO No. 993/2018 dated 10 August 2018, S.R.O. 1067(I)/2018 dated 04 August, 2018, S.R.O. No. 1152(I) dated 18 September 2018, and S.R.O No. 1260(I) dated 10 October, 2018 issued by the Federal Government to apply measures to give effect to United Nations Security Council Resolutions 1718 (2006), 1874 (2009), 2087 (2013), 2094 (2013), 2270 (2016), 2321 (2016), 2356 (2017), 2371 (2017), 2375 (2017) and 2397 (2017) adopted under Chapter VII of the Charter of the United Nations.

2. On 16 October 2018, the Security Council Committee established pursuant to Resolution 1718 (2006) Committee designated the following three vessels pursuant to paragraph 12 of resolution 2321 (2016) and 6 of resolution 2371 (2017) as under:

***Vessels subject to de-flagging pursuant to paragraph 12 of resolution 2321 (2016) and prohibited from port entry pursuant to paragraph 6 of resolution 2371 (2017):***

- i. ***Shang Yuan Bao***      IMO: 8126070
- ii. ***New Regent***      IMO: 8312497
- iii. ***Kum Un San 3***      IMO: 8705539

3. The measures detailed in paragraph 12 of the UN Security Council resolution 2321(2016) and paragraph 06 of UN Security Council resolution 2371(2017) will apply to the above notified vessel **including prohibiting the entry into the ports**. Paragraph 12 of UNSC resolution 2321(2016) and paragraph 06 of 2371(2017) shall also continue to apply to all other vessels designated by the UN Security Council as listed in Annex (available at <https://www.un.org/sc/suborg/en/sanctions/1718/materials/list-of-designated-vessels>). All relevant measures specified from time to time in the SRO's referred to in paragraph 1 above will apply to all the vessels designated by the UN Security Council and any future modification in the list.
